Being a By-law to Amend By-law No. 2018-16

WHEREAS By-law No. 2018-16 regulates the use of land and the use and erection of buildings and structures within the Township of Matachewan;

AND WHEREAS the Council of the Corporation of the Township of Matachewan deems it advisable to amend By-law No. 2018-16 as hereinafter set forth;

NOW THEREFORE the Council of the Corporation of the Township of Matachewan enacts as follows:

- 1. The properties affected by this By-law are located in Part Lot 12, Con F, Kimberly Township; BLK A PL M277TIM; PINs 612630037, 612630038, 612630039, Rye Street, Township of Matachewan, as indicated by the shaded tone on Schedule 'A' attached hereto and forming part of this Bylaw.
- 2. By-law No. 2018-16 is hereby amended as follows:
 - Townsite Map (Schedule B) of By-law No. 2018-16 is hereby (a) amended by rezoning the affected properties from Development (DE) Zone to General Residential Special Exception 4 (R1-4) Zone in accordance with the provisions of this By-law.
 - (b) By-law No. 2018-16, as amended, is hereby further amended by adding the following text in the heading to Section 5.4(d), following "By-law 2006-16":
 - "and By-law 2009-06)"
 - (c) By-law No. 2018-16, as amended, is hereby further amended by changing the numbering of subsections (3) and (4) in Section 1 to 1.3 and 1.4.
 - (d) By-law No. 2018-16, as amended, is hereby further amended by adding the following Section after 1.4:
 - 1.5 Amending By-laws

Note that where amending by-law numbers are referenced in text, they are provided for reference only, and upon consolidation with this By-law are repealed.

This By-law shall come into full force and effect in accordance with the 3. Planning Act, R.S.O. 1990.


